The American Legion Auxiliary (ALA) Foundation's purpose is to ensure the long-term sustainability of the ALA. The Foundation's ALA Mission Endowment Fund, a long-term fund from which net investment earnings from the endowment's principal are dedicated to support the mission of the ALA, granted \$23,258 to the ALA Girls Nation program. The ALA Foundation awarded \$33,885 via third party sub-grants that supported youth, education, and veterans programs. The ALA Foundation awarded the ALA \$39,600 to support its co-presentation of the National Veterans Creative Arts Festival that rewards the artistic achievements of veterans receiving art therapy through the VA healthcare system, and awarded \$13,800 to departments supporting local veterans creative arts festivals. The ALA Foundation awarded \$28,375
