The ALA Foundation awarded \$36,875 via third party sub grants that supported youth, education, veterans programs, and personal protective equipment for the ALA staff. The ALA Foundation awarded the ALA \$39,600 to support its co- presentation of the National Veterans Creative Arts Festival that rewards the artistic achievements of veterans receiving art therapy through the VA healthcare system, and additionally awarded \$7,920 to affiliates supporting local veterans creative arts festivals. The ALA Foundation awarded \$35,510 that supported emergent needs of veterans. The ALA Foundation awarded \$14,731 to departments supporting mission delivery.

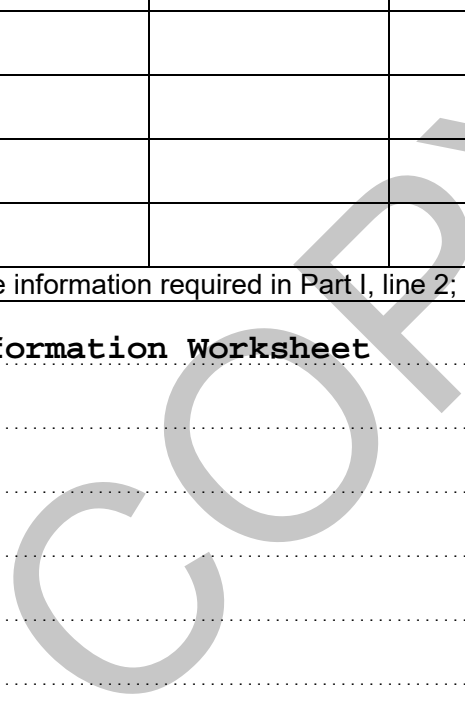
