



The American Legion Auxiliary (ALA) Foundation's purpose is to ensure the long-term sustainability of the ALA. The Foundation's ALA Mission Endowment Fund, a long-term fund from which net investment earnings from the endowment's principal are dedicated to support the mission of the ALA, granted \$23,059 to the ALA. The ALA Foundation awarded \$58,000 via third party sub-grants ranging from \$500 to \$25,000 to ALA national, 3 ALA departments, and 1 ALA unit that supported youth, education, and veterans' programs. The ALA Foundation awarded the ALA \$54,107 to support its co-presentation of the National Veterans Creative Arts Festival that rewards the artistic achievements of veterans receiving art therapy through the VA healthcare system and awarded \$7,500 via 3 mini-grants to 3 departments
